JOB SUMMARY:

Teaches history and chairs departmental meetings and appoints committees, works with Deans, Department Chairs, Deputy Chairs, and faculty, coordinates content of courses, coordinates selection process, supervises and evaluates Department Chairs with Deans and Directors, ensures ongoing faculty evaluation and development. Responds to student's requests and provides guidance to faculty on grading and academic issues.

JOB RESPONSIBILITIES:

Responsibilities include, but not limited to the following:

- Teaches three (3) courses in History
- Chairs departmental meetings and appoint department committees; serves as formal conduit of information with academic administration
- Works with Deans, Department Chairs, Deputy Chairs, and faculty to establish department goals and objectives and program assessment activities, and takes leadership to implement program reviews
- Coordinates content of courses offered by different academic units, and oversees overall consistency, currency and quality of department curriculum, catalogue materials, faculty examinations, and classroom syllabi
- Coordinates the selection process of department chair, deputy chair, coordinator, as well as oversee faculty selection
- Supervises and evaluates Department Chairs together with Deans and Director of academic units

- Ensures ongoing faculty evaluation and development
- Coordinates teaching and course schedules with Department Chairs and Deputy Chairs
- Ensures departmental representation at meetings, faculty orientation and development events
- Responds to student appeals and requests, and provide guidance to faculty on grading and academic integrity issues
