HISTORY OF TOURO LEADERSHIP

Bernard Lander, Ph.D., of Blessed Memory Founder and First President of Touro College and Touro University

Dr. Bernard Lander, an inspirational leader and visionary, founded Touro College in 1970 and served as its first president until his passing in February 2010. Under his stewardship, Touro underwent significant growth, becoming an institution with multiple campuses and international reach. Today, Touro educates approximately 19,000 students across the United States and around the world, and Dr. Lander's creative genius and original thinking continues to be reflected in Touro's innovative approach to the field of higher education.

Before founding Touro College, Dr. Lander served as associate director of former New York City Mayor Fiorello LaGuardia's Committee on Unity, a precursor to the city's Commission on Human Rights. In 1958, he was appointed dean of the Bernard Revel Graduate School of Yeshiva University, where he played a major role in the establishment of a network of graduate schools. Dr. Lander was also a professor of sociology at The City University of New York and he was selected to serve on several presidential commissions that dealt with social policy issues.

Alan Kadish, M.D. President and CEO of the Touro College & University System

In 2009 Dr. Alan Kadish was appointed as senior provost and Chief Operating Officer of the Touro College and University System, and after Dr. Lander's death, he was selected to serve as the institution's second president.

Prior to joining Touro, Dr. Kadish distinguished himself as a prominent cardiologist, dedicated teacher and researcher and an experienced administrator. He taught at the University of Michigan and enjoyed a 19-year tenure at Northwestern University, where he served as the director of the cardiovascular clinical trials unit, and on the finance and investment committees of the Northwestern clinical practice plan. Dr. Kadish has published over 250 peer-reviewed papers, contributed to several textbooks and received numerous grants. He is board certified in internal medicine, cardiovascular disease and cardiac electrophysiology.

Since taking the reins from Dr. Lander, Dr. Kadish has expanded the college's unique programs for Jewish and underserved communities, positioned it as a top-tier institution for the study of health sciences and he continues to guide Touro toward the highest levels of educational achievement and academic excellence.

To promote and support faculty and student research and scholarship


To develop and provide educational opportunities to underserved students in diverse communities







Age of Enrolled Students Touro College, New York Fall Semesters, 2011 to 2015





Touro College New York**








Average Net Price of Attendance, 2013-14



(3) The total cost to attend that school (tuition, room and board, books and supplies) weighted for the length of time it takes most students to graduate with a bachelor's degree.
